

Camp Cedar Illinois Inc. COVID Policies 2021

(to be updated as new information is obtained)

COVID-19 General Policies:

- 1. Practice Social distancing guidelines while on campus.
- 2. Agree to comply with signage related to wearing face coverings.
- 3. Agree that when unable to social distance and/or in settings that require mixing with other groups, face covering to be worn.
- 4. If overnights open back up, when sleeping in bunk rooms, sleepers must stagger upper and lower bunks.
- 5. Bathrooms will be disinfected twice daily.
- 6. If you are experiencing any of the following COVID-19 symptoms, it is important that you protect yourself and others by staying home:
 - a. Fever of over 100.4 in the past 48 hours
 - b. Shortness of breath of difficulty breathing
 - c. New loss of taste or smell
 - d. Chills
 - e. Nausea, diarrhea, vomiting
 - f. Head or muscle aches
- 7. Please stay home if you have tested positive for COVID-19 in the past 20 days.
- 8. Please stay home if you have been in direct contact with a positively tested COVID-19 patient within the last 20 days.
- 9. If you feel you are a high risk of experiencing complications of COVID-19, please carefully consider your attendance to camp.

Proactive Safety Measures:

- 1. Initial health screening before coming to camp including:
 - a. Temperature check
 - b. Symptom check
 - c. Short questionnaire to parent/guardian
- 2. Frequent washing of hands
- 3. Masks to be worn indoors
- 4. Children will have their own markers, colored pencils, songbooks, etc.
- 5. Minimizing sharing of indoor crafts and materials
- 6. Pre-packaging of certain crafts

In the Event of a Potential Exposure:

- 1. Immediate removal of child from the group & contact parent/guardian
 - a. We will have a health area where the child can stay until they can be picked up!
- 2. Inform parents/legal guardians about a potential exposure to their child.
- 3. Take temperatures and see if anyone else is experiencing any symptoms.
- 4. Immediately inform parents/legal guardians if their children are experiencing any symptoms.
